Instructions and conditions:

- 1. All the rates shall be filled up in figures as well as words in English only without fail.
- 2. The rates and amount against each item shall be filled up only in the quotation form enclosed
- 3. The quotation shall be duly signed by the competent person.
- 4. The quotation shall be liable for rejection if any one of the above said requirement are not complied with.
- 5. The quotation must reach at the office of undersigned on or before 2:00PM on date 17/03/2020
- 6. The quotation will be opened on 17.03.2020 at 03.30 pm. in Government Polytechnic Gariyaband.
- 7. The bidder shall lift the material from the premises after payment of full amount within the prescribed time limit, failing which they will cease the right to lift the material and the payment deposited shall stand forfeited.
- 8. No partial quantity in one time will be issued.
- 9. Quantities of Scrap may be divided among Parties in the case of quoting same rate on same item at the discretion of Government Polytechnic Gariyaband.
- 10. The bidder shall clear the material out of the premises at its own arrangements/ cost, etc.
- 11. All the intending bidders may inspect the scrap put up for disposal during the working hours of the institute. In any case it will be presumed that they have inspected and verified themselves about the material before quoting.
- 12. The quotation will be rejected if the rate is not above the offset value/salvagevalue as decided by the competent authority.
- 13. Government Polytechnic Gariyaband reserves the right to reject / partly accept, any or all offers without assigning any reasons whatsoever.
- 14. If any party emerges as higher bidder for any items (s) and if the party does not lift any of the material within stipulated time, then order will be cancelled.

- 15. The sale of items shall be on the basis of the highest rates quoted for each item subject to other conditions. Based on the highest offer for individual items. Sale shall be made separately for each item to the highest bidder.
- 16. The highest bidder is required to deposit the estimated total value within 10 working days after opening of quotation, failing which the entire sell order of such bidder shall be cancelled and Government Polytechnic Gariyaband shall be free to offer it to the next bidder or to cancel the quotation for that item only.
- 17. The material shall be lifted on the basis of actual measurement / weight taken/ quantity in the presence of the representative of Government Polytechnic Gariyaband after paying full value of the material, within 3 working days from the campus of the institute after payment of the estimated total value of the items offered to such bidder.
- 18. The bidder has to settle all the payments before issuing Gate Pass.
- 19. Taxes @ % direct or indirect (if any) will be charged extra as per prevailing rate on MRP of the scrape material.
